

2015 USIHC Annual Meeting Minutes

March 7, 2015 Nokomis Room, Radisson Blu Hotel, Minneapolis, MN

The meeting was called to order at 9:30AM by USIHC President, Sara Lyter.

Sara thanked all participants for attending and the Flugnir Club for co-hosting the meeting, followed by introductions of the remainder of the current USIHC Board of Directors:

To kick off the meeting, Barbara Frische gave a lecture about the Young Horse Evaluation Linear Form using three fictional horses to demonstrate how the process and form is used to help determine if the horse is ideal for show or leisure riding.

Following Barbara's presentation were summaries of the 2014 reports from the various USIHC committees, as presented by either the committee Chairs, or their BOD Liaison. Committee reports are attached to the minutes.

At the conclusion of the Breeding Report, Andrea Barber asked FEIF International Breeding Judge and member of the the Breeding Judges' Committee Barbara Frische to speak about the new procedure for selecting judges for breeding shows.

Andrea Barber gave a detailed background and explanation of the proposed Blood Profile Project which the USIHC is currently pursuing with the help of researchers from Cornell University.

Kari Pietsch-Wangard reviewed the 2014 Financial Report for USIHC, explaining all areas of USIHC income and expenses for that fiscal year.

Doug Smith reported on the status and trends of USIHC membership, including graph charts he developed that clearly demonstrated the numbers as he explained them.

Dave and Eve Loftness, members of the Flugnir Club, gave an interesting and entertaining presentation about American Competitive Trail Horse competitions, which are judged trail rides complete with obstacles that horses and riders navigate in a fun, yet competitive atmosphere.

Their presentation included demonstrations of some obstacles using two teams or “horses” and “riders”, balloons, hula-hoops, and even Icelandic chocolate bars.

USIHC has a very special award, the Sleipner Award, that is presented to a person who demonstrates going above and beyond for the benefit of the Icelandic Horse breed in this country, or for the USIHC. The USIHC BOD presents this award at those times a member has clearly demonstrated the spirit of the award.

Dawn Shaw was announced as a recipient of the Sleipner Award for her tremendous efforts assisting with the rehoming and registering of a very large number of Icelandic Horses over the past few years. Without her efforts of explaining to new owners why registration was so important, and the step by step assistance she gave them from start to finish of the registration process, it is possible that many of these horses would have remained unregistered and without any proof of their identity as purebred Icelandic Horses.

The winners of the 2014 Breed Ambassador Award were also named at the Annual Meeting, by way of a random drawing of all members who entered the contest. The Breed Ambassador Award acknowledges those members who participate in organized all-breed events with their Icelandic Horses with winners receiving a \$50 Visa gift card and an official USIHC Breed Ambassador shirt. The Flugnir Club generously donated a variety of equestrian themed door prizes that were given away to the attendees of the Annual Meeting via random drawing. A total of 12 beautiful prizes were given away to very lucky and very happy winners.

The meeting turned to a general discussion forum between the attendees and the BOD. A wide variety of topics were discussed, many of which will be referred to the appropriate USIHC committee for further discussion and or development. The discussion was very interesting, and likely would have continued on into the evening if not for time constraints. Many excellent suggestions were made. Throughout the discussion, members were encouraged to join the committees that best represent their interests. Some of the key topics discussed were:

- 1) The benefits of being a USIHC and/or Regional Club member and what other types of benefits might be offered to members.
- 2) Increasing educational opportunities to members, especially leisure riders.
- 3) The preservation of trail riding areas for horses – how can USIHC and/or the Regional Clubs help in this effort?
- 4) Keeping the flow of communication going between the BOD, members and Regional Clubs

The final presentation of the meeting was on Equine Dentistry, given by Laurelyn Turbes, who enhanced her presentation with a slide show and a full size model of an equine skull. Basic dental care along with some common issues with the teeth and gums were covered, along with some advancements in equine dentistry.

2014 Secretary's Report

General Duties

Most of the general duties of the Secretary are not particularly interesting to report. Agendas and minutes were prepared according to the normal time schedules for all Board teleconference calls. Routine updates were made to the website news and calendar pages as requested by the various committee chairs, board members, and the membership at large. All items posted to the news and calendar pages are automatically sent to the Congress Facebook page.

All the routine correspondence with our parent organization, FEIF, was completed in a timely manner.

The regularly scheduled farm and mailing lists were provided to the Quarterly committee to aid in the publication of the magazine.

Assistance was given to the Election Committee in preparing for the annual Board election. Once again, the election was canceled by the Board under the powers granted by the Constitution when no candidates were nominated to challenge the incumbent members.

Membership


A much more interesting topic is the status of the Congress membership. The membership has been closely tracked in a database integrated into the web site since 2007/2008. From this time on, all membership records have been logged to give the Board a clear insight into the expansion and retention of the membership.

The membership trend in the Congress continues following the traditional pattern. As evident in the graph below, the overall pattern of membership is extremely closely tied to the historic January 1st expiration date.

There is a slight shifting of the curve between 2012 and 2014. Some of this shift can be attributed to the free youth memberships offered for 2014. There is also a slight shifting caused by late renewals.

Households by Start of Membership Year




As seen in the previous chart, the overall status of the membership remains fairly constant over time. It is worth noting, however, there is a high amount of turnover from year to year. The following shows the number of memberships by year and type that have been allowed to lapse since they were created.

This proves to be a slightly difficult statistic to research. For the sake of simplicity, each column each column represents the memberships of a given type last active in the shown year. For example, in 2007 there were 98 individual memberships not renewed.

There is likely some degree of “false positive” cases where a youth or family membership ends because a child reaches majority and is forced to join as an individual. This is not a significant number.

There is also a “false positive” opportunity if a membership expires and is restarted as a new membership rather than a renewal. The design of the membership database attempts to minimize such cases by enforcing uniqueness of email addresses. Again, there is not likely to be a significant number of memberships that are replaced by new ones where it is truly the same person using a different email address.

One other note regarding the data. The extremely high number of unrenewed “Junior” memberships from 2013 reflects the program of offering free memberships for young people during the period from September 2013 to September 2014. Many of these memberships were for extremely young children or at addresses with normal, paid memberships. It is not surprising, therefore, many of these memberships were not continued once the free period expired.




The clearest conclusion is there is a routine turnover in the membership that amounts to almost 25% of the normal household threshold in any given year. This observation indicates the challenge to the Congress is not as much growth as it is retention.

Further analysis of the un-renewed memberships shows the vast majority of them are only one or two years old. Members who stay over two years tend to stay for the long haul. A very small number reach back to the start of the online membership database.

USIHC QUARTERLY COMMITTEE 2014 ANNUAL REPORT

Nancy Brown and Nicki Esdorn, co-chairs



2014 was a big year for *The Icelandic Horse Quarterly*, marking our upgrade to a full-color magazine. Thanks to the USIHC Board for supporting our initiative, co-chair Nicki Esdorn for spearheading the redesign effort, co-chair Nancy Brown for dealing with the design & printing details, and our 15 committee members and up to 49 contributors per issue (more than 10% of the total USIHC membership!) who provided the exceptional content and editorial oversight that makes the *Quarterly* such an effective “face” of the USIHC.

As FEIF Leisure Riding Leader Lone Høgholt wrote upon receiving the March 2015 issue: **“This is an amazingly good magazine! Just spent half morning reading very good and qualified articles. WOW – well done!”**

The goals of the Quarterly Committee are to educate and entertain the membership; to provide a communication channel for the Board, the Committees, and the members; and to promote the USIHC and the breed by showing the versatility of the Icelandic horse and focusing on its health and welfare in the U.S. In 2014, the committee renewed its commitment to presenting “best practices” in both text and photographs. We also stated a goal of featuring young and upcoming riders and trainers. Articles in the magazine covered all facets of the Icelandic horse world, including interviews with riders, trainers, and breeders; updates on research projects; reports from shows and evaluations; training tips; travel essays; youth essays; film and book reviews; members’ experiences and reflections; and news from the Regional Clubs, USIHC Committees, the USIHC Board of Directors, and FEIF. We also developed three pages to promote the USIHC and the Registry; these pages, “Why Join the USIHC” and “Why Register Your Icelandic Horse,” are now standard in the magazine and updated as necessary.

Each of the four 2014 issues of *The Icelandic Horse Quarterly* was 52 pages long, in full color with a heavier cover stock, and featured a total of 31 feature articles and numerous news items written and illustrated by committee members and other USIHC members. Advertising pages were increased, with advertising placement now available in both the front and the back of the magazine (thanks to Quarterly committee member and Promotion chair Juli Cole for that suggestion!). Advertising income for the year was \$4,425. The Committee continues to offer free advertising to Regional Clubs or individual members

to promote USIHC-sanctioned events and programs, such as shows, evaluations, clinics, or special offers (i.e., the Youth Membership Drive).

Total Quarterly expenses, for design, printing, and mailing, were \$15,934, according to treasurer Kari Pietsch-Wangard, who has been vital in helping us keep our bills, as well as our advertising, on track. The issues were released electronically as PDF files and posted by USIHC webmaster Doug Smith on www.icelandics.org on approximately Feb. 15, May 15, August 15, and November 15; they were mailed approximately two weeks later. As they are mailed at the most economical bulk rate, copies were received by all members by approximately March 15, June 15, September 15, and December 15.

This year, following a revision of the Quarterly Copies Policy in the USIHC Policies & Procedures manual, Nicki Esdorn made a concentrated effort to reach out to all contributors and make sure they each received two free contributors' copies. Contributors are encouraged to share their free copies with potential new members or otherwise use them to promote the USIHC and the breed.

The number of copies in 2014 varied issue to issue:

- March: 1300 copies (446 USIHC members, 580 for membership drive, 221 for Promotion, remainder for contributors and welcome packets)
- June: 650 copies (450 USIHC members, 30 Promotion, remainder for contributors and welcome packets)
- September: 600 copies (476 USIHC members, 50 Promotion, remainder for contributors and welcome packets)
- December: 600 copies (436 USIHC members, 50 Promotion, remainder for contributors and welcome packets)

As of November 2014, we had only 11 copies of the March issue left (out of 1300 printed), 37 copies of June (out of 650), and 2 copies of September (out of 600), meeting our goal of having all copies distributed to interested readers within 6-9 months of their issue date.

For our March 2014 membership drive, we shared 580 copies of the magazine with potential new USIHC members; these were distributed with the help of 29 trainers and breeders who each reached out to 20 potential members. Although the success of the drive is hard to assess--given that, overall, USIHC members in December 2014 was similar to that of March 2014--the trainers and breeders involved were enthusiastic. We felt it was a cheap and easy way to generate good will, to introduce new Icelandic horse riders/owners to the USIHC, and eventually, we hope, to increase our membership numbers. Everyone on our list was very happy and appreciative—and thankful!—to receive free copies to give to their clients. As reported in the March 2015 issue, here's what they told us:

- They were **great handouts** for people interested in the breed and the Icelandic Horse Scene.
- It is such **an excellent promotional tool**; not only is the magazine beautifully designed and informative, it also shows people who are new to the breed **what a fun community the Icelandic horse world in America is!**
- Countless people pick them up and read them, even those who are not horse people. **They really help with encouraging interest in the breed.**
- I have many newbies who are not sure it's worth joining the USIHC as **they don't know what they will get from the membership**, especially if they don't own a horse. I think getting an issue of the *Quarterly* would sway them for sure!
- It's a **great good will gesture that builds interest and excitement** about the breed.

- With every horse and every lesson package we sell, we include a copy of the *Quarterly*. We would love to continue to do this and **encourage people to become members**.

In conjunction with the membership drive, Quarterly co-chair Nicki Esdorn volunteered to take over the job of sending out Welcome Packets to new USIHC members. From March to November 2014, she sent out 65 Welcome Packets.

In addition to producing four spectacular issues of *The Icelandic Horse Quarterly*, our committee projects for 2015 include:

- surveying our readers,
- generating more advertising,
- providing more coverage of Icelandic-horse related content found on the web,
- preparing an index (or table of contents) of our web archive of back issues,
- posting more *Quarterly* content as individual stories on the USIHC website,
- working with the Registrar to ensure that each new Icelandic horse owner receives a complimentary copy of the *Quarterly*,
- working with the Education Committee to post our trainer profile series on the website,
- working with the Youth Committee to develop a Youth Essay Contest,
- working with the Leisure Riding Committee to develop a profile series,
- working with the Regional Club Committee to see that all clubs are represented in our Regional Club Updates section,
- working with the Promotion Committee to expand the use of the *Quarterly* as a promotion and membership-recruitment tool by offering free copies (while supplies last) to any USIHC member who requests them (as well as to trainers, breeders, and Regional Clubs).

Committee membership for 2014 averaged 15 members, still all women—we again hope to recruit some male USIHC members to contribute their insights. More women are always welcome on the committee too. We hope you'll join us.

2014 Promotion Committee Report

The Promotion Committee developed an exciting new program in 2014 titled the Breed Ambassador Award, the purpose of which is to recognize those members who take their Icelandic Horses to organized all-breed events.

The program was open to all USIHC members in good standing, provided that they were current members both at the time of the event used for entry and at the time the winners were announced at the 2015 Annual Meeting.

Entries were made by submitting photos either to the USIHC Facebook page, or emailing them directly to the Promotion Committee Chair. Five winners were selected by random drawing at the 2015 Annual Meeting and each winner receives a \$50.00 Visa Gift Card and an official USIHC Breed Ambassador Award T-shirt.

Participation was good for the initial year, with a total of 27 entries. The program will continue for 2015 and it is anticipated that participation will increase.

2014 Breeding Evaluations

2014 Annual Report - Standard Blood Profile Project

For many years the USIHC has pursued getting a Standard Blood Profile for the Icelandic breed. The USIHC regularly gets contacted by both owners and veterinarians with sick Icelandic horses questioning the blood test results they are getting – not sure if deviations from normal values are due to illness, or from breed characteristics. Having a Standard Blood Profile for the breed would be extremely helpful to allow veterinarians to have normal values for the Icelandic breed to compare to when analyzing data from their own testing. Unfortunately, to date completion of this project has proved elusive mostly due to the necessity of having a large number of Icelandic horses in a single place for testing.

However, the fact that Cornell University has a herd of Icelandic horses on site revived interest in this project. The researcher in charge of the study involving the Icelandic horses (also a USIHC member) – [Bettina Wagner, DVM, Dr. med. vet. habil.](#) – was contacted and she was extremely willing to help with regard to this new project. She conducted some preliminary sampling at her own expense (which showed good promise) and then brought in clinical pathologist [Tracy Stokol, DVM, Phd.](#) (also from Cornell University) to consult further.

The USIHC board then held a conference call to discuss the project with both professionals. Many questions were answered, and shortly thereafter the board decided to move forward with the project (pending negotiation of a contract with Cornell University as to the details of the project, which is currently in progress) – as it seemed to provide the potential for great benefit to the breed both here in the US and around the world.

However, completion of this complex project will involve a Herculean effort on the part of the USIHC's entire membership. Over 120 horses will need to be sampled under strict parameters set by the researchers. These samples will then need to be tested by Cornell's lab at a cost of approximately \$14,000 – which the USIHC has agreed to pay for, but which we hope will be offset, at least in part, by USIHC member contributions. The results of those tests will then need to be analyzed by the research team and then put into two formats – one that is easily accessible by the layman for owner use and the other suitable for publication in a peer-reviewed academic journal for veterinary use. Though of course we will all be eager for the results, we must be patient as good, sound science takes time.

We hope that all USIHC members will support his important project in 2015 and beyond!
