

2015 Secretary's Report

The membership numbers of USIHC averaged 450 households +/- each month. The total number of individual members (adult and youth) averaged 625 +/- each month.

The duties of the Secretary's office include preparing the agenda for the monthly BOD conference calls and the minutes from each monthly call. Requests are sent to each committee Chair to submit any reports about the activities of each committee or items such as proposals for events or funding that require action (voting) from the BOD for each month's call. A new sub-committee of native german-speaking people was built in order to complete the translations. Almost all topics are translated and are currently in the process of being checked by Kari Pietsch Wangard.

We will be able to finish this project very soon.

Edition Riding badge materials

Coralie Denmeade is still working on the edition of the riding badge materials, developed by Bernie Willis.

Thank you very much to the Quarterly Committee who provided their help with photos and illustrations in order to give it an appealing design.

This will also be finished very soon and will then, once it is checked, be posted on the USIHC webpage and be ready to use for instructor and participants of future riding badge courses.

Development of a promotion video

A sub-committee was built in order to develop a promotional video, originally planned to be posted on the USIHC webpage, accessible to the public.

The video has been created by Lisa Keller. The Board decided to table it.

We thank Lisa very much for all the effort and time she put in this work!

It cannot be taken for granted when members sacrifice their time to support the USIHC.

We greatly appreciate it.

Discussions about future trainer courses and ongoing educations

We were discussing a lot the future of the trainer course system as well as the development of ongoing trainer educations.

Details are not defined yet but we will offer ongoing education seminars for US trainers and judges as of next year.

Planned activities 2016

- ongoing education seminars for US Sport judges, 2 dates per year
- ongoing education seminars for US trainer
- 3rd sport judge seminar with Þorgeir Guðlaugsson during a sanctioned show (will be accepted as further education for judges)
- further discussions and results regarding trainer educations, possibly resulting in organizing a trainer course

2015 Promotion Committee Report

2014 was the inaugural year for the USIHC Breed Ambassador Award. To be eligible to participate USIHC members in good standing attended a variety of organized all-breed events with their registered Icelandic Horses and submitted photos showing their participation in the event either directly to the Promotion Committee Chair, or by posting them on the USIHC Facebook page. A member could enter as many times as they wished. Five “Ambassadors” were chosen by random drawing at the 2015 USIHC Annual Meeting. Each winner received a \$50 Visa gift card and an official USIHC Breed Ambassador T-shirt.

There were 25 entries for 2015 and the winners were Jane Wasson, Gloria Verrecchio, Grace Strausser, Alice Ryan and Dorothy Connors.

The Breed Ambassador Award continued into 2015 and the winners will be drawn and announced at the 2016 Annual Meeting in Portland, OR.

Another printing of the USIHC brochure was done in 2015 to supply demand for the brochures. The brochures are available free of charge to any USIHC member or Regional Club to distribute at their events.

Regional Club Annual Report 2015

The Regional Club Committee spent quite a bit of time working on establishing protocol and means of distribution of funds from the Congress to the Regional Clubs for educational purposes. The following was submitted to the Board for consideration:

The Regional Club committee began discussion in June about ways to facilitate funding to Clubs for educational events. The consensus seems to be that there needs to be a system in place for the Clubs to ask for funds which is not overly burdensome to either the Club or the USIHC. The discussion began to hinge on whether or not a flat fee rate was the best way to go, or to provide funds on a sliding scale on an event by event basis. The flat fee seems to make more sense to the majority of Committee members. This was based on the fact that if each Club had to submit financial details of a given event (for example flight expenses, daily clinical fees, etc) it could easily become a nightmare. So, it was decided that a flat fee of \$500.00 would be appropriate. Since there are currently 10 Clubs, it would allow the USIHC to budget \$5000.00 and it would allow each Club to budget a potential of \$500.00 support from the USIHC.

The discussion continued as to how to allocate the funds. One of the suggestions was that perhaps the USIHC should give the Clubs the funds to do with as they wished. This is not feasible since there has to be a value to the Club hosting the event as well as the USIHC. If the funds were provided and used for activities which did not align with the mission of the USIHC, or for simply recreational activities for the members, that was not appropriate. That said, some of the guidelines that were established were that the funds would have to be used for educational purposes with a Clinician who is a certified Icelandic trainer. There was no restriction on whether the funding would be used to further the Clubs abilities in showing, breeding, pleasure riding, dressage\{2026}\.whatever discipline. In this way, the funds would be inclusive of all members. I did not see where we had a restriction on how the funds would be used (purchasing air fare, meals, etc.) as long as they were used in support of the approved clinic.

The funds would be made available on a first come first served basis, based on the date of the ask, not the date of the event. It was determined to be the only fair way to do it. There are some Clubs who establish their calendars earlier than others, but this would provide incentive to get the calendar established as early as possible. The discussion then went further as to what percentage of Club members needed to also be members of the USIHC to qualify for funding. Currently, Associate Members are allowed in Clubs. It is believed in the future a percentage of those members will also have to be members of the USIHC for any funding to be provided, but at the current time, that is not the case. In order to qualify to request funding, the Club would have to have all of their documentation and renewals on file with the USIHC and be in good standing.

We, as a Committee, are willing to design a form for submission to the USIHC to ask to funding.

Our proposal to the board was as follows:

The Regional Club committee began working on an efficient and fair way to allocate funds to the Clubs for educational purposes. After much discussion it was felt fair that the USIHC allocate \$500 to each Club yearly with the following parameters...

1. The Club must be in good standing with the USIHC.
2. The requesting Club must fill out a request form to the USIHC and submit it to request the

- funds. It is not automatic. The committee is working on designing a form which is user friendly for both the Club as well as the USIHC.
3. The educational activity for which the Club is requesting funds must be conducted by a certified Icelandic trainer/clinician. This will make sure the event is in alignment with the goals and the structure of the USIHC.
 4. If a Club does not use their funds in a given year, those funds are lost. There will be no rollover nor sharing of funds between Clubs.
 5. A summary of the activity along with photos must be submitted for inclusion in the Quarterly.

The \$500 figure was derived by taking \$5000 and dividing it between the 10 established Clubs. If the number of Clubs raises or falls, the dollar amount will be raised or lowered accordingly. Currently there is no rule in place about the percentage of Club members who are also required to be USIHC members to qualify for funding. If that changes in the future, the policy of allocation will change to reflect this.

The Regional Club committee, after much discussion, feels that this is a simple and straightforward way to offer financial help to the Clubs for educational events.

The Board tabled the proposal until the 2016 Budget meeting. They asked the Regional Committee to address the following:

1. The Board would like the Regional Club Committee to address expanding the language of the proposal to include allowing clinicians who are accredited with a recognized organization outside of the Icelandic Horse community.

The Committee did open discussion on this issue and to date they feel that it should remain as originally proposed, that the clinician does need to be a certified Icelandic trainer/clinician. Other trainers/clinicians would offer valuable information, because they would offer a wonderful foundation and supplementation, but the Committee feels that Congress funds would be used to support the very specific challenges of riding Icelandic horses.

2. The BOD also requested that the Regional Club Committee address the issue of the percentage of Regional Club members who are not USIHC members to those who are USIHC members as it relates to potential funding.

The Committee opened discussion on this issue. Since there is no current requirement for a set number of members (other than the founding 5) to be members of the USIHC as well as members of the Regional Club, until the rule is changed, the Club is in good standing. A Club in good standing with the USIHC should be eligible to request funding for educational purposes. The idea was that if the USIHC showed support to the Regional Chapters in this way, that the USIHC support of the Regional Clubs would make the USIHC more visible to the local membership, and that would enhance the chances that the Congress itself will attract and maintain more members.

Some Clubs have a greater percentage of Congress members than other Clubs. By keeping the requirement for the trainer/clinician to be a Certified Icelandic trainer/clinician, there is a direct benefit to the Congress as well as for the Club.

2015 Annual Breeding Report

2015 Breeding Evaluations

- A breeding evaluation was held May 27-28, 2015 judged by International Breeding Judges Marlise Grimm (DE) and Elisabeth Jansen (IS). It was held at Léttleiki Icelandics in Shelbyville, KY. Unfortunately, it was a rather small event with only a total of five horses evaluated – two for full evaluation and three for conformation only. To fill up the additional time a “practice” breeding evaluation was held for all that wished to participate as several riders and horses had arrived early for the sport show scheduled directly after the breeding evaluation. This was very well received.

Looking ahead to 2016:

- A fall breeding evaluation to be held in KY is in the planning stages

2015 Young Horse and Foal Assessments

- A new sanctioning process was established to ensure adherence with FEIF rules
- Only one Young Horse and Foal Assessment was held in 2015 - despite the additional funding offered. The event was held directly after the full breeding evaluation and the judges were Marlise Grimm (DE) and Barbara Frische (US). A total of five young horses were evaluated.

2015 Awards

- The highest assessed young horse of the year and the winner of the [Caryn Cantella Award](#) was Ástarljós from Pegasus Flughestar (US2013204810) bred and owned by [Kathryn Ruth Love](#). More information on the award, the winner, and a list of the top 10 horses (5 this year) from 2015 can be found on the [USIHC website](#).

- The highest evaluated US bred horse and winner of the [Anne Elwell Award](#) was Marel from Creekside Farm (US2010104426) with a total score of 8.11. Marel was bred by Barbara Frische and owned Creekside Farm Rutledge LLC (Katrin Sheehan) and Nicole Kempf.
- Also of note, gelding Ali from Dalalif (US2007103535) ridden by his owner Lucy Nold achieved a total score of 7.96. Ali was bred by Anne-Marie Martin.

YOUTH COMMITTEE REPORT TO USIHC December 8, 2015

Youth Events in 2015

It was a very exciting year for young Icelandic Horse riders in the United States. Across the United States, young Icelandic horse riders once again participated in sanctioned shows, clinics, camps, schooling shows and community events with their Icelandic Horse partners.

Additionally, the United States sent two young riders from Alaska to the FEIF Youth Camp in Berlar, Germany in July. There the two young women had the opportunity to meet other young people from around the world who share their passion and enthusiasm for Icelandic horses. Brooke Weirheim wrote about her experience, saying *“If you like meeting people from around the world, having fun, exploring new places, being silly, and riding Icelandic horses, this camp would be perfect for you!...I made so many friends that I will keep in touch with.”* That sentiment is exactly why the Youth Committee was so happy to send these young people as representatives of young American Icelandic horse devotees.

Our flagship event for the year was, of course, the first-ever American Youth Cup, held in Kentucky in July. This momentous event brought together twenty young riders from across the country, from Alaska to Vermont and many states in-between, together for the first time to learn, compete, and build life-changing relationships for a full week with each other and their Icelandic horses. This was no small feat. Organizers meticulously prepared everything including food, lodging, events, communications, photography, show coordination, leisure activities, education, training, and leadership. Judges, trainers, scribes, team leaders and chaperones were recruited and organized. Horses were donated and brought in from as far away as New York, Florida and Wisconsin so that each young rider had a horse partner that was appropriate to their riding level, and so that no riders had the advantage of riding their own horse when others could not. The event was modeled after the FEIF Youth Cup, with approximately three days of training with highly-qualified instructors and team leaders, followed by two days of competition. Classes included standard competition classes such as T1, V1, F1 and T3, as well as Dressage and trail classes. Intermixed with these events were educational opportunities such as a day trip to the Kentucky Horse Park, and a visit to one of the nation’s premier equine veterinary clinics.

The Youth Committee is grateful to the USIHC for its support for this event. USIHC provided a Grant to the event of \$3400 to support its members who participated. The Youth Committee used the \$3000 profit from the 2009 FEIF Youth Camp and the Sanctioned show open to the public qualified for \$1000.

The Spaeri Youth Award

The Spaeri Award was established in 2014 to be given annually to a youth who clearly demonstrates commitment to and love for Icelandic horses. Recipients are selected from USIHC youth who submit articles to the Quarterly demonstrating these sought-after qualities. The 2014 winner, Quinn Thomashaw, was selected at the end of 2014. Another winner will be selected at the end of this year. Along with the Award the winner will receive \$50.

FEIF Youth Cup 2016

The Youth Committee is pleased to report that it has received eight applicants for the FEIF Youth Cup in 2016. This is the largest number of applicants received by the committee to date, from the most diverse locations including Maine, Vermont, New York and California. The Youth Committee is preparing and reaching out to Icelandic horse people who could facilitate horse and tack rental. The committee anticipates appealing to FEIF once again for more slots than the three annually allotted for the US Team. Video applications have been sent to Porgeir Gudlaugsson for scoring and participants will be selected in order of the scores received and the riders application.

Encouraging Ongoing Involvement by Young Adult Riders

So, what happens to our young riders when they "graduate" out of our youth programs? Young Adult riders (ages 18-25) may find it more difficult to make time for their Icelandic horse partners and activities when the pressures of college and career set in. The Youth Committee is aware of this problem, and we are proud to say that we are making great progress in keeping our young adults involved in our programs even after they have exceeded the age of youth riders. The Youth Committee and our local clubs encourage riders who have "aged out" of events to return and help with leadership and organization of the events. For example:

- The American Youth Cup organizers recruited Kevin Draeger (20), Madison Prestine (21), and Ayla Green (21), all former FEIF Youth Cup participants, to lead the AYC teams.

- American Youth Cup organizers created an award specifically designed to encourage young adult riders to return to assist with the program, offering older AYC rider Julia Hasenauer a scholarship to return to the AYC as a team leader in a future year.
- The Youth Committee is actively recruiting young adult riders to participate as Team and Country Leaders in the 2016 FEIF Youth Cup.
- Local clubs in California and Kentucky have sent several young adult riders to Iceland for training. Alexandra Venable (CA) spent a summer in Iceland training and now is among the young adult leaders at a very active youth training facility in CA. Ayla Green (CA) is currently in Iceland working with Gudmar Petursson in preparation for future studies at Hölar University. Caeli Cavanaugh (VT) is currently enrolled at Hölar. Carrie Brandt (KY) and Laura Benson (CA), have already completed Hölar training and are actively training and recruiting youth riders in the US to the sport.
- In California, New York, Iowa, Minnesota and other US States young adult riders organize and lead youth events such as group trail rides, camps, and parades.
- Farms across the US offer internships and other work opportunities for young adult riders. Californians Ayla Green and Alexandra Venable both interned at Leittliki Icelandics in Kentucky, and Vermont native Caeli Cavanaugh completed an internship at a youth training facility in California before enrolling at Hölar.
- Young adult riders are taking leadership positions in local clubs. Kevin Draeger (20) is Vice President of Flugnir, the Icelandic Horse Association of the Midwest.

Membership

There are 12 Icelandic Horse clubs registered with the USIHC. Youth membership climbed slightly in 2015, with approximately 110 youth riders in local clubs and an estimated 80 in the USIHC. Youth numbers remain difficult to track because they are typically listed as family memberships in an effort to preserve youth privacy. In total there are approximately 428 Household (Family) memberships in 43 of the 50 US States. It is difficult to quantify how many individual youth that includes, as a household membership may include only adults or multiple youths. The three largest clubs in the United States, the North Eastern Icelandic Horse Club (NEIHC), Flugnir in the Midwest, and the Northern California Icelandic Horse Club (Kraftur) boast approximately 70 youth members between them.

USIHC QUARTERLY COMMITTEE 2015 ANNUAL REPORT

Nancy Brown and Nicki Esdorn, co-chairs



In 2015 the 17 members of the Quarterly Committee, led by co-chairs Nicki Esdorn and Nancy Brown, produced four 52-page full-color issues of *The Icelandic Horse Quarterly*. A consistent 40-50 contributors per issue (about 10% of the total USIHC membership) provided the exceptional content and editorial oversight that makes the *Quarterly* such an effective “face” of the USIHC.

The goals of the Quarterly Committee are to educate and entertain the membership; to provide a communication channel for the Board, the Committees, and the members; and to promote the USIHC and the breed by showing the versatility of the Icelandic horse and focusing on its health and welfare in the U.S.

In 2015, the committee surveyed its readers, receiving comments from more than 300 individuals (USIHC members and nonmembers). The survey was a direct outgrowth of the discussion at the 2015 USIHC Members Meeting, organized by the Flugnir Club and held in Minneapolis, MN. Thanks go to everyone who attended the meeting, as well as to Kathy Love, Emily Hackett, and Anne Elwell for nudging us toward an online survey, and to Board member Doug Smith for taking the survey itself from vague idea through data collection and analysis. The questions were written by Nicki Esdorn, Nancy Brown, and Anne Owen of the Quarterly Committee, and committee member Chris Romano created the advertisement. The survey closed June 26, and we reported the results that applied to the *Quarterly* in the September issue. For most respondents to the survey, the USIHC’s most valuable service is providing access to a network of Icelandic horse enthusiasts and professionals: 79% said this function was “very important” or “important,” while only 4% found it “somewhat important” or “not important.” The USIHC’s second most valuable service, the survey said, is the *Quarterly* (78%).

We’re very pleased with the success of this effort to reach out to Icelandic horse owners and riders in the U.S. and we hope to repeat the survey in 2016. The many thoughtful comments we received directed our editorial decisions as we planned the remaining 2015 issues and began those for 2016. The survey results showed that Icelandic horse owners in the U.S. overwhelmingly want the *Quarterly* to print stories about Training (basics, groundwork, training methods, clinic reports, and fitness) and Horse Care (keeping, grooming, health issues, and feeding), and that they would like those stories to be written (or

at least checked) by a professional. Those topics have long been a priority for the Quarterly Committee as well. We have two certified Icelandic horse trainers on the committee and are trying to recruit more. All articles and photos are reviewed for “best practices”—as defined by FEIF and USIHC policies—by the pros on our committee, and we occasionally do reject submissions on those grounds.

According to the survey, next in importance to our readers come USIHC News, the history of the Icelandic horse, and Regional Club Updates (over 70% of readers liked these topics). Over 60% of respondents found FEIF News, the Farm List (which is a paid advertisement), articles on Breeding and Sport Events, and Trainer Profiles to be “important” or “very important.” Farm profiles, the Editorial, and Icelandic horse Vacations were chosen by over 50% of respondents. The least popular stories in the *Quarterly* are Member profiles (42%) and Youth essays (28%). We will keep this in mind when accepting or rejecting submissions and when making article assignments. Youth essays, whether published or not, will be entered into the contest for the yearly Spaeri Award, a collaboration between the Quarterly Committee and the Youth Committee.

Many suggestions in the survey’s comments section reinforce what the Quarterly Committee has been striving to achieve, such as: be inclusive; show the versatility of the horse; cover the whole country; remember most of us are leisure riders; include more photos, more letters, more advertising, more contact information, and more cartoons.

Other ideas are ones we hope to be able to follow up on, such as:

- more articles from professional trainers
- a yearly summary on breeding, including the number of foals, popular sires, number of horses evaluated, etc.
- more information about tack, health concerns, basic horse care (and caring for the older horse), new products on the market, how to choose a horse, horse behavior
- articles on Icelandic horse vacations and camping opportunities in the U.S.
- an annual or online index of past *Quarterly* stories
- and more interviews with people doing unusual things with their horses.

A good suggestion was to “repeat general knowledge roughly every 4 years to catch new Icelandic owners.” One we will not be able to follow up on, due to time and money, is “go monthly.”

Articles printed in 2015 covered all facets of the Icelandic horse world, including coverage of the American Youth Cup; interviews with trainers, breeders, and leisure riders; clinic reports and training tips; articles on horse health and welfare; articles on the psychology of riding; award announcements; reports from breeding evaluations; travel essays; youth essays; and news from the Regional Clubs, USIHC Committees, the USIHC Board of Directors, and FEIF. We also continued updating and printing the three pages designed in 2014 to promote the USIHC and the Registry, “Why Join the USIHC” and “Why Register Your Icelandic Horse.”

Advertising pages continued to increase, with advertising placement available in both the front and the back of the magazine. The Committee continues to offer free advertising to Regional Clubs or individual members to promote USIHC-sanctioned events and programs, such as shows, evaluations, or clinics (i.e., the Kentucky Judging Seminar).

Total 2015 Quarterly income from advertising and expenses, for design, printing, and mailing, can be found in the treasurer’s report; we thank Kari Pietsch-Wangard for helping us keep our bills, as well as

our advertising income, on track. The issues were released electronically as PDF files and posted by USIHC webmaster Doug Smith on www.icelandics.org on approximately Feb. 15, May 15, August 15, and November 15; they were mailed approximately two weeks later. As they are mailed at the most economical bulk rate, copies were received by all members by approximately March 15, June 15, September 15, and December 15.

In 2015 we printed 650 total copies per issue and individually mailed 464 copies in March, 490 in June, 469 in September, and 502 in December to USIHC members and Quarterly contributors. Following the Quarterly Copies Policy in the USIHC Policies & Procedures manual, Nicki Esdorn made a concentrated effort to reach out to all contributors and make sure they each received two free contributors' copies if they wanted them. Contributors are encouraged to share their free copies with potential new members or otherwise use them to promote the USIHC and the breed. Copies for personal use, as per our policy, cost \$5 each and are mailed by Nicki; thanks to Kari for handling the invoicing. Copies enclosed in Welcome Packets to new USIHC members, or Replacement Copies for copies lost or damaged in the mail, are also handled by Nicki; in 2015 she sent out 84 Welcome Packets and Replacement Copies.

The Promotion Committee received 50 copies per issue to use at events; event organizers needed to contact Promotion Chair Juli Cole to receive those free copies. This process seems to be too complicated, as sometimes Juli runs out of issues and Nicki still has some, and vice versa. As of December 1, there are only 5 copies of the March issue left and 6 copies of June (the plan worked perfectly for these issues). Together we have 100 copies left of the September issue; these copies will be used to fill the next requests. The December copies for Promotion, Welcome Packets, and Replacement copies have not yet been sent out, as the December issue is still in the mail as of this writing. The Quarterly Committee is discussing with the Promotion Committee how to streamline the procedure, get a better idea of what is needed, and save on postage. We propose to have a single stockpile of extra copies and for the Quarterly staff (thanks to Nicki Esdorn for volunteering) to mail out all requests, whether they come through the Quarterly channel or the Promotion channel. Nicki will keep an account of what purpose the issues are mailed for.

Kara Noble, who handled the NEIHC booth at Equine Affaire in Massachusetts, reported that the NEIHC distributed 100 copies of various 2015 issues of the *Quarterly* at the event in November. "And we made sure they went to qualified folks too—people who were serious about the horses, but who (for the most part) were not yet members of the USIHC or the NEIHC or any other regional group," Kara wrote. "We talked to three people who had recently adopted Icelandics from the Cornell herd used in the studies of summer eczema, one who had recently adopted a mare at a local auction, several people who were in the process of negotiating a sale, and quite a few who told us they had been researching various breeds and had recently decided that they had chosen Icelandic horses as the right breed for them. We were able to talk to hundreds of people—most of whom we grabbed when they stopped in the aisle to watch the videos we were running.... It was a great way to get the word out."

In addition to producing four spectacular new issues of *The Icelandic Horse Quarterly*, our committee projects for 2016 include:

- surveying our readers again and providing the content that most interests them,
- generating more advertising,
- preparing an index of our web archive of back issues,

- working with the Registrar to ensure that each new Icelandic horse owner receives a complimentary copy of the *Quarterly*,
- working with the Education Committee to post our trainer profile series on the website,
- collaborating with the Youth Committee on the Spaeri Youth Essay Contest,
- working with the Regional Club Committee to see that all clubs are represented in our Regional Club Updates section,
- supporting the Leisure Riding Committee,
- working with the Promotion Committee to refine the use of the *Quarterly* as a promotion and membership-recruitment tool.

Committee membership for 2015 reached 17 members, still all women—we again hope to recruit some male USIHC members to contribute their insights. More women are always welcome on the committee too. We hope you'll join us.

2015 Annual Report – Blood Profile Project Update
